A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

LRH-2010-58-GUY-ISOLATED WATERS-RR7-ABUT WL 13-SCOUR D

RR7 is ephemeral and has an OHWM for 759 lf. WL 13 is located on the prelaw bench and is abutting the reach. It was observed in the field to originate at WL 13 on the prelaw bench then flow off the bench and down grade and have no surface or consolidated subsurface connection to a water of the U.S.

LRH-2010-58-GUY-ISOLATED WATERS-RR13-UPLAND-DRAIN T

RR13 has a poorly defined discontinuous OHWM in natural topography where a stream channel may be present. However, RR13 is not considered a channel. RR13 is above the prelaw bench and it was observed in the field to end before reaching the prelaw bench.

LRH-2010-58-GUY-ISOLATED WATERS-RR15-UPLAND-DRAIN K

RR15 has a poorly defined discontinuous OHWM in natural topography where a stream channel may be present. However, RR15 is not considered a channel. RR15 is above the prelaw bench and it was observed in the field to end before reaching the prelaw bench.

LRH-2010-58-GUY-ISOLATED WATERS-RR26-NON JD SCOUR

RR26 is ephemeral and has an OHWM for 250 lf. It was observed in the field to originate at the prelaw bench and flow down grade and have no surface or consolidated subsurface connection to a water of the U.S. WL 1 is located in close proximity to RR26, but no culvert or connection could be established.

LRH-2010-58-GUY-ISOLATED WATERS-RR27-UPLAND-ABUT WL1,2 AND OPW 4-DRAIN WL1-2

RR27 has a poorly defined discontinuous OHWM located entirely on the prelaw bench. RR27 is not considered a channel. WL 1, WL 2, and OPW 4 are located on the prelaw bench and are abutting the reach. It was observed in the field to originate to the southeast of WL 2 and OPW 4 and flow northwest into WL 1. WL 1 had no outlet or drainage, and there was no surface or consolidated subsurface connection to a water of the U.S.

LRH-2010-58-GUY-ISOLATED WATERS-RR32-ABUT WL 4-DRAIN L

RR32 is ephemeral and has an OHWM for 3100 lf. It was observed in the field to originate above the prelaw bench and flow down grade onto the prelaw bench where WL 4 is located then off the bench and down grade for several hundred more feet. The end of channel was observed to have no surface or consolidated subsurface connection to a water of the U.S. The reach ends in overgrown secondary growth shrubs and into a reclaimed AML grassy area. RR32 is located in close proximity (parallel) to RR30, but no culvert or connection could be established. Between RR32 and RR30 is a gas pipeline and abandoned access road. During high flow events some water may flow from RR30 to RR32, however it does not appear that water could flow from RR32 to RR30.

LRH-2010-58-GUY-ISOLATED WATERS-RR42-ABUT OPW 3-DITCH Q

RR42 is ephemeral and has an OHWM for 319 lf. OPW 3 is located on an access road and is abutting the reach. It was observed in the field to originate at OPW 3 and in close proximity to isolated WL 14, WL 14A, and OPW 3A. RR42 has no surface or consolidated subsurface connection to a water of the U.S.

LRH-2010-58-GUY-ISOLATED WATERS-RR49-1RUT OF DRAIN L

RR49 is ephemeral and has an OHWM for 152 lf. It is a very short drain into RR32. See RR32 above.
