This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. The Summit County Soil Survey mapping shows an intermittent stream in the vicinity of the current stream; however, the flow of the stream and drainage patterns on-site have been modified due to the various land use activities over the years. Based on the consultant's observations during different days and years and on the observations in the field during the 2 July 2012 Corps site visit, this stream carries water seasonally/intermittent based on the presence of pools, a moist channel and a very low level of flowing water present in the channel.

Summarize overall biological, chemical and physical functions being performed: Wetland 9 (approximately 1.65-acres) is a large forested wetland (PFO) that has portions which are seasonally inundated. Wetland 9 abuts an RPW, (Stream E, the unnamed tributary to Willowdale Lake) which flows off-site. Wetland 9 provides flood storage and filtering functions for the watershed, and aids in maintaining and improving water quality in the tributary system. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland 9 (approximately 1.65-acres) is a large forested wetland (PFO) that has portions which are seasonally inundated. Wetland 9 abuts an RPW, (Stream E, the unnamed tributary to Willowdale Lake) which flows off-site and is connected to the tributary system of the Tuscarawas River, TNW. Wetland 9 has the capacity to carry flood waters, contribute to the capacity of the system to transfer nutrients and organic carbon that support downstream food webs and reduce the amount of pollutants reaching the TNW. Wetland 9 is directly connected to Stream E. Stream E in combination with Wetland 9 provide more than an insubstantial or speculative effect on the water quality of the Tuscarawas River, a TNW, and meets the Significant Nexus Standard (SNS) .
