The approved JD boundary contains two isolated wetlands (Wetland W1 and Wetland W3) totaling 0.117 acre. The wetlands are low-quality palustrine emergent wetlands. Wetland W1 (0.111 acre) and Wetland W3 (0.006 acre) formed in depressions and are dominated by Reed Canary Grass, a non-native invasive plant. Both wetlands are isolated with no hydrologic connection to the tributary system and no substantial nexus to interstate or foreign commerce. The wetlands are located 150-200 feet from a channelized intermittent unnamed tributary to Muchinippi Creek. However, the wetlands did not have a swale or other drainage features connecting them to a water of the U.S. The wetlands are located on the existing wastewater treatment property in a mowed/maintained field. The region is predominantly agricultural, however the approved JD boundary has not been in agricultural use for 30+ years. There was insufficient information to make a determination regarding previous prior converted cropland or NRCS designation, and the wetlands were determined to be isolated.

The site contains two wastewater treatment ponds (Pond P1 and Pond P2) totaling 5.5 acres. Both ponds were created by excavating dry land to collect and retain water and which are used exclusively for treating wastewater and are not considered jurisdictional waters of the U.S (33 CFR 328.3(a)). Ponds P1 and P2 are not considered jurisdictional waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetlands W1 and W3 are surrounded by uplands, with no hydrologic connection to the tributary system. There is no indication of interstate or foreign commerce associated with the wetlands, and the wetlands do not provide suitable habitat for endangered species.

The isolated wetland determination was coordinated with the Corps HQ and USEPA Region 5 for isolated waters coordination, in accordance with Corps and USEPA headquarters guidance entitled, "Revised Guidance on Clean Water Act Jurisdiction Following the U.S. Supreme Courts Decision in *Rapanos v. United States* and *Carabell v. United States*," and the 28 January 2008 Corps Memorandum regarding coordination on jurisdictional determinations. The coordination period ended on 6 February 2014. This JD was submitted in association with a NWP application, however based on this approved JD there would be no impacts to waters of the U.S. and a permit would not be required.
