Upon review of the Soil Survey mapping, the aforementioned wetland is located in a mapped upland soil series. Review of the USGS topographic and the site visit did not verify a hydrologic connection to a water of the US. Three jurisdictional wetlands totaling 0.666 acres are located on the project site.
