- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

The Fairborn Expansion Area of Interest (AOI) is characterized by active agriculture activities, access roads, utility line right-of-ways, and forested areas. On 3 October 2017, this office received a request for a jurisdictional determination titled *Request for an Approved Jurisdictional Determination* report, dated 27 September 2017, and prepared by CBC Engineers & Associates, Ltd. (CBC) on behalf of Fairborn Cement Company (Fairborn). During this review of the project, the Corps requested additional information required to accurately describe and delineate waters within the Fairborn Expansion AOI. Additional information was received by our office 30 November 2017.

Based on a review of the 27 September 2017 report submitted to our office, additional information received 30 November 2017, and other data available to us, this office has determined that only non-jurisdictional waters are present within the five (5) approved jurisdictional determination (JD) boundaries. The seven (7) approved JD boundaries contain seven (7) isolated, non-jurisdictional streams totaling 1,574 linear feet (0.152 acre).

Stream A –Upstream Route 235, Stream G, Stream J, Stream K, Stream L, Stream N, and Stream I (1,574 lf or 0.152 acres): These ephemeral stream channels exhibited a defined bed and bank (DBB) and ordinary high water mark (OHWM) for 1,574 lf. Stream A – Upstream Route 235 flows to Route 235 which results in loss of DBB and OHWM. Stream G flows off-site into a residential pond that has no outlet, and is surrounded entirely by uplands. Stream N flows through an active agriculture field and loses gradient, DBB, and OHWM. Stream J, Stream K, Stream L, Stream N, and Stream I are stream channels surrounded entirely by uplands. There was no evidence of a hydrologic surface or consolidated subsurface connection to a water of the U.S. Therefore, this office has determined that these features are isolated, non-jurisdictional stream channels, not subject to regulation under Section 404 of the Clean Water Act.

Refer to the enclosed *Fairborn Expansion Aquatic Resources – Approved JD Table*, and *Fairborn Expansion Jurisdictional Boundary Map* for a detailed summary of the non-jurisdictional features. The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States and Carabell v. United States.*"

(perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
