**Buckeye Minerals Services on behalf of Oxford Mining Company, LLC. Submitted a report entitled *404 Individual Permit Application for Besozzi Mining Area for the Besozzi Mine Site*, received by this office on 19 October 2015. The approximately 120 acre site is located within Section 32 of Rush Township Tuscarawas County, Ohio. An approved JD was issued for the area on December 17, 2010, and has since expired.**

**The subject review area included as Relevant Reach 1 consists of areas of steep slopes. Some previous mining activities have been conducted in upper reaches of the site based on the provided mapping. Much of the area is in active agriculture, some of which is in hay, and the upper reaches are forested. Evidence of previously installed tiles was located on the site. The tributaries on-site drain into an unnamed tributary to Stillwater Creek.**

**On 6 April 2016 this office conducted a field investigation to verify the stream and wetland delineation associated with the permit application.**

**Based on a review of the 4 May 2016 report submitted to our office, and other data available to us, this office has determined that both jurisdictional and non-jurisdictional waters are present within the Besozzi Mine Area. Our December 2, 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States* and *Carabell v. United States*" was followed in the final verification of Clean Water Act jurisdiction.**

**The AJD boundary contains four constructed ponds (EWI 1, EWI 2, EWI 3 and EWI4) and two disconnected linear features (S-1 and S-2). These six linear features do not exhibit ordinary high water marks, defined bed and banks, wetland characteristics, or relatively permanent flows. Therefore, these six features are not considered waters of the U.S. and are not subject to regulation under Section 404 of the Clean Water Act.**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
