- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

O'Brien & Gere Engineers Inc. submitted the report titled *Grand Communities LLC Jurisdictional Waters Determination Report Shaker Run Planned Unit Development Turtle Creek Township, Warren County, Ohio* dated September 24, 2019 for the proposed site. As part of the Project, a wetland assessment and delineation survey was completed on the Site by O'Brien & Gere Engineers, Inc., a Ramboll company (Ramboll) on October 29-30, 2018 and August 14, 2019. Two non-jurisdictional swales (totaling approximately 234 LF) were identified on-Site.

Based on a review of the report submitted to our office, this office has determined that non-jurisdictional waters are present within the approved jurisdictional determination (JD) boundary. The approved JD boundary contains two (2) non-jurisdictional swales (totaling approximately 234 LF) that lack defined bed, banks and ordinary high water mark. Swale 7 and Swale 9, totaling approximately 234 LF, were observed within the Site and did not exhibit defined stream characteristics. Representative photographs of the swales are presented in the report. Therefore, Swales 7 and 9 are non-jurisdictional features that are not subject to regulation under Section 404 of the CWA.

The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States* and *Carabell v. United States*."

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
