Explain: Stream 2 conveys storm water to the tributary system. The stream is shallow, relatively straight, and does not support a wide riparian corridor as it flows through a primarily agricultural area. The stream does not have adjacent or abutting wetlands and supports a very limited watershed (18 acres). Given that the unnamed tributary is nearly six (6) miles as the crow flies from the nearest traditional navigable water (Tuscarawas River), it is unlikely the very low functions provided by this

waterway would have an effect on the Tuscarawas River. The stream does not have more than speculative or insubstantial effect on the chemical, biological, or physical integrity of the Tuscarawas River. Therefore, Stream 2 is determined NOT to have a significant nexus to the Tuscarawas River.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Mud Lake is part of Turkeyfoot Lake, which then flows to West Reservoir of the Portage Lakes through a connection channel, which flows to East Reservoir of the Portage Lakes, through the outflow to Long Lake and finally flowing to the Tuscarawas River. Given that the unnamed tributary is nearly six \(6\) miles as the crow flies from the nearest TNW \(Tuscarawas River\), it is unlikely the very low functions provided by this waterway would have an effect on the Tuscarawas River. The stream does not have more than speculative or insubstantial effect on the chemical, biological, or physical integrity of the Tuscarawas River.](#)
