This office received a stream and wetland delineation report, Schramm Surface Coal Mine USACE Investigation of Waters of the U.S. (25 March 2015), prepared by Kleski Environmental Services (Kleski) on behalf of B&N Coal, Inc (B&N). Members from the United States Army Corps of Engineers (Corps), Kleski, B&N, Ohio Division of Natural Resources (ODNR), Ohio Environmental Protection Agency – Division of Surface Water, and State Historic Preservation Office/Ohio History Connection participated in an on-site field investigation conducted on 3 June 2015. During these investigations the Corps requested additional information required to accurately describe and delineate waters within the delineation boundary. Final revisions were received by our office 31 January 2017.

Based on a review of the 25 March 2015 and 28 February 2016 reports submitted to our office, on-site field verification conducted on 3 June 2015, final revisions received 31 January 2017, and other data available to us, this office has determined that both jurisdictional and non-jurisdictional waters are present within the study area. The approved JD boundary contains twenty-nine (29) non-jurisdictional features. This includes: six (6) non-jurisdictional features totaling 1,777 linear feet (lf); fifteen (15) isolated open water features totaling 2.21 acres; and, eight (8) isolated emergent wetlands totaling 0.45 acres.

The proposed Schramm Surface Coal Mine area has been extensively altered by pre-law mining. Large highwalls, pit impoundments, and overburden piles have severely altered the drainage patterns and topography of the area.

As shown on the enclosed "Approved JD Table" and wetland delineation map, eight isolated wetlands are located within delineation boundary. These wetlands appear to be driven by precipitation, are surrounded by uplands, and lack an apparent surface hydrological connection to a surface tributary system. The closest surface tributary is approximately 200 feet away from wetlands PP-C1 and PP-Y; approximately 300 feet away from wetland PP-Q; and approximately 400 feet away from wetlands PP-F, PP-F4, PP-G, PP-T, and PP-U. In addition to being hydrologically isolated from a surface water tributary system, these wetlands do not appear to support interstate or foreign commerce interests nor do they contain any rare or endangered species. Based on this information, these wetlands are isolated and are not jurisdictional waters of the United States.

The 15 open water features and streams do not exhibit a surface water connection to tributary system and are thus not considered to be jurisdictional waters of the United States.

The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in Rapanos v. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
