This office received a stream and wetland delineation report, titled *Wetland and Stream Delineation Report, Foster Run Mitigation Bank, Tyler County, West Virginia* (10 February 2016), prepared by Civil & Environmental Consultants, Inc. (CEC) on behalf of Resources Environmental Solutions, LLC (RES). Members from the United States Army Corps of Engineers (Corps) and EBX-EM participated in an on-site field investigation on 1 March 2016. During these investigations the Corps requested additional information required to accurately describe and delineate the waters within the delineation boundary. Final revisions were received by our office on 1 August 2016.

Based on a review of the 10 February 2016 report submitted to our office, on-site field verification conducted on 1 March 2016, final revisions received 1 August 2016, and other data available to us, this office has determined that both jurisdictional and non-jurisdictional waters are present within the study area. A Preliminary JD has been completed for the proposed jurisdictional waters. The approved JD boundary contains forty (40) non-jurisdictional features and four (4) isolated emergent wetlands. This includes: forty (40) non-jurisdictional features totaling 9,382 linear feet (lf); and, four (4) isolated wetlands totaling 0.082 acre.

The project area is characterized by pasture land, access roads, timbering, along with various forms of utility development. The area has been impacted by past land use activities which has altered the drainage patterns and topography of the area.

Based on the above referenced information, this office has determined that there are forty (40) non jurisdictional features totaling 9,382 lf and four (43) isolated wetlands totaling 0.082 acre, not subject to regulation under Section 404 of the Clean Water Act. These features did not exhibit a hydrologic surface or consolidated subsurface connection to a water of the U.S.

The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States* and *Carabell v. United States*." Refer to the enclosed: *Foster Run Mitigation Bank – Approved JD Table, Foster Run Stream and Wetland Delineation Map (June 2016)*; for a detailed summary of the non-jurisdictional features.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
