This office received a stream and wetland delineation report, Preliminary Jurisdictional Determination Report Cline Run Mitigation Bank Site (18 November 2015), prepared by Decota Consulting Company, Inc (Decota) on behalf of Resources Environmental Solutions, LLC (RES). In addition, this office received a stream and wetland delineation report, Lizzies Roost Run Stream and Wetland Delineation Jurisdictional Determination Report –Extension of Cline Run Mitigation Bank (9 June 2016), prepared by EBX-EM, on behalf of RES. Members from the United States Army Corps of Engineers (Corps) and EBX-EM participated in on-site field investigations conducted on 23 January 2016, 23 February 2016, and 20 July 2016. During these investigations the Corps requested additional information required to accurately describe and delineate waters within the delineation boundary. Final revisions were received by our office 8 June 2016 and 7 October 2016.

Based on a review of the 18 November 2015 and 9 June 2016 reports submitted to our office, on-site field verifications conducted on 23 January 2016, 23 February 2016, and 20 July 2016, final revisions received 8 June 2016 and 7 October 2016, and other data available to us, this office has determined that both jurisdictional and non-jurisdictional waters are present within the study area. The approved JD boundary contains twenty (20) non-jurisdictional features and three (3) isolated emergent wetlands. This includes: twenty (20) non-jurisdictional features totaling 4,813 linear feet (lf); and, three (3) isolated wetlands totaling 0.032 acres.

The project area is characterized by pasture land, access roads, timbering, along with various forms of utility development. The area has been impacted by past land use activities which has altered the drainage patterns and topography of the area.

Based on the above referenced information, this office has determined that there are twenty (20) non jurisdictional features totaling 4,813 lf; and, three (3) isolated wetlands totaling 0.032 acres, not subject to regulation under Section 404 of the Clean Water Act (CWA). These features did not exhibit a hydrologic surface or consolidated subsurface connection to a water of the U.S.

The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in Rapanos v. United States and Carabell v. United States." C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
