Explain: **Non-Jurisdictional Channel 1 receives drainage from storm water runoff via a culvert from an east-adjoining industrial complex located in uplands, flows west across the northern portion of the**

proposed project area for approximately 676 linear feet, and terminates in a storm drain on the northwestern corner of the proposed project area. The storm drain appears to discharge into a detention basin on the corner of Northwest Boulevard and West Crescentville Road. The detention basin does not have an outlet and does not connect to a surface tributary system. The closest jurisdictional stream (unnamed tributary to Mill Creek) to the channel is approximately 4,300 feet away. The channel is surrounded by upland herbaceous vegetation, does not present a hydrologic connection to waters of the United States and does not have a nexus to interstate or foreign commerce. The channel does not support commercial fish species, is not used for agricultural irrigation, and does not exhibit wetland characteristics. It appears the channel was constructed historically for storm water management. Prior to it being constructed, no stream was present within the project area. Non-Jurisdictional Channel 1 is not a jurisdictional water of the United States.

Wetland A (0.35), Wetland B (0.322 acre), and Wetland C (0.04 acre) are surrounded by uplands, do not present a hydrologic connection to waters of the United States and do not have nexuses to interstate or foreign commerce. These wetlands do not support commercial fish species and are not used for agricultural irrigation. The closest jurisdictional stream to the wetlands is approximately 3,300 feet away. Therefore, Wetlands A-C are isolated wetlands and are not jurisdictional waters of the United States. Additionally, Ditch 1 (approximately 147 lf) originates and terminates in upland areas in the eastern portion of the proposed project area. Ditch 2 (approximately 174 lf) originates in an upland area and terminates in a storm drain in the western portion of the proposed project area. Neither Ditch 1 nor Ditch 2 exhibited a defined bed and bank, an ordinary high water mark, or wetland characteristics. Therefore Ditch 1 and Ditch 2 are not jurisdictional waters of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
