Explain: Based on a review of the information provided and other information available to us, the approximate 1,062 acre study area contains forty-nine (49) geographically isolated, non-jurisdictional wetlands

(Wetlands 4-19, 27-30, 33, 39-41, 47, and 50-73). Wetlands 4-19, 27-30, 33, 39-41, 47, and 50-73 were likely created as a result of development and agricultural activities in the surrounding area. Wetlands 4-19, 27-30, 33, 39-41, 47, and 50-73 are completely surrounded by uplands and have no distinct surface water connection to a water of the United States. Wetlands 4-19, 27-30, 33, 39-41, 47, and 50-73 would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species.

The closest stream proximity to the above listed wetlands are as follows:

Stream 1 to wetland 41 approximately 400 linear feet,

Based on the above reasons, Wetlands 4-19, 27-30, 33, 39-41, 47, and 50-73 are not considered jurisdictional waters of the United States.

The site also contains Ponds 1 and 8-11 (approximately 2.92 acres). Ponds 1 and 8-11 appears to be man-made, excavated water features that are deeper than 6.5 feet, have not been created by the impoundment of a jurisdictional stream, and do not have a surface water connection to traditional navigable waters. Therefore, Ponds 1 and 8-11 are not considered jurisdictional waters of the United States.

analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
