connection nor is it separated from a relatively permanent water by a berm/barrier. Wetland W-2 is approximately 1,147 feet to the west from the nearest RPW (unnamed tributary to Swartz Ditch). In addition to being hydrologically isolated from a surface tributary system, Wetland W-2 is neither used to irrigate crops nor does it appear to have any recreational value supporting interstate or foreign commerce. In addition, this wetland does not contain any rare or endangered species. Therefore, Wetland W-2 is determined to be a non-jurisdictional, isolated aquatic resource not subject to regulation under Section 404 of the Clean Water Act.

Wetland W-3 is an approximate 0.027 acre palustrine emergent wetland that does not directly abut a relatively permanent water. Wetland W-3 is not adjacent to a relatively permanent water through discrete hydrologic connection or ecological connection nor is it separated from a relatively permanent water by a berm/barrier. Wetland W-3 is approximately 852 feet to the west from the nearest RPW (unnamed tributary to Swartz Ditch). In addition to being hydrologically isolated from a surface tributary system, Wetland W-3 is neither used to irrigate crops nor does it appear to have any recreational value supporting interstate or foreign commerce. In addition, this wetland does not contain any rare or endangered species. Therefore, Wetland W-3 is determined to be a non-jurisdictional, isolated aquatic resource not subject to regulation under Section 404 of the Clean Water Act.

Wetland W-4 is an approximate 0.024 acre palustrine emergent wetland that does not directly abut a relatively permanent water. Wetland W-4 is not adjacent to a relatively permanent water through discrete hydrologic connection or ecological connection nor is it separated from a relatively permanent water by a berm/barrier. Wetland W-4 is approximately 978 feet to the west from the nearest RPW (unnamed tributary to Swartz Ditch). In addition to being hydrologically isolated from a surface tributary system, Wetland W-4 is neither used to irrigate crops nor does it appear to have any recreational value supporting interstate or foreign commerce. In addition, this wetland does not contain any rare or endangered species. Therefore, Wetland W-4 is determined to be a non-jurisdictional, isolated aquatic resource not subject to regulation under Section 404 of the Clean Water Act.

Wetland W-5 is an approximate 0.042 acre palustrine emergent wetland that does not directly abut a relatively permanent water. Wetland W-5 is not adjacent to a relatively permanent water through discrete hydrologic connection or ecological connection nor is it separated from a relatively permanent water by a berm/barrier. Wetland W-5 is approximately 725 feet to the northeast from the nearest RPW (unnamed tributary to Swartz Ditch). In addition to being hydrologically isolated from a surface tributary system, Wetland W-5 is neither used to irrigate crops nor does it appear to have any recreational value supporting interstate or foreign commerce. In addition, this wetland does not contain any rare or endangered species. Therefore, Wetland W-5 is determined to be a non-jurisdictional, isolated aquatic resource not subject to regulation under Section 404 of the Clean Water Act.

Wetland W-6 is an approximate 0.010 acre palustrine emergent wetland that does not directly abut a relatively permanent water. Wetland W-6 is not adjacent to a relatively permanent water through discrete hydrologic connection or ecological connection nor is it separated from a relatively permanent water by a berm/barrier. Wetland W-6 is approximately 1,142 feet to the west from the nearest RPW (unnamed tributary to Swartz Ditch). In addition to being hydrologically isolated from a surface tributary system, Wetland W-6 is neither used to irrigate crops nor does it appear to have any recreational value supporting interstate or foreign commerce. In addition, this wetland does not contain any rare or endangered species. Therefore, Wetland W-6 is determined to be a non-jurisdictional, isolated aquatic resource not subject to regulation under Section 404 of the Clean Water Act.

Wetland W-9 is an approximate 0.107 acre palustrine emergent wetland that does not directly abut a relatively permanent water. Wetland W-9 is not adjacent to a relatively permanent water through discrete hydrologic connection or ecological connection nor is it separated from a relatively permanent water by a berm/barrier. Wetland W-9 is approximately 882 feet to the west from the nearest RPW (unnamed tributary to Swartz Ditch). In addition to being hydrologically isolated from a surface tributary system, Wetland W-9 is neither used to irrigate crops nor does it appear to have any recreational value supporting interstate or foreign commerce. In addition, this wetland does not contain any rare or endangered species. Therefore, Wetland W-9 is determined to be a non-jurisdictional, isolated aquatic resource not subject to regulation under Section 404 of the Clean Water Act.

Wetland W-10 is an approximate 0.308 acre palustrine emergent wetland that does not directly abut a relatively permanent water. Wetland W-10 is not adjacent to a relatively permanent water through discrete hydrologic connection or ecological connection nor is it separated from a relatively permanent water by a berm/barrier. Wetland W-10 is approximately 964 feet to the northeast from the nearest RPW (unnamed tributary to Swartz Ditch). In addition to being hydrologically isolated from a surface tributary system, Wetland W-10 is neither used to irrigate crops nor does it appear to have any recreational value supporting interstate or foreign commerce. In addition, this wetland does not contain any rare or endangered species. Therefore, Wetland W-10 is determined to be a non-jurisdictional, isolated aquatic resource not subject to regulation under Section 404 of the Clean Water Act.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
