Report”, submitted by EnviroScience on behalf of Richard A. Currie, Ed.D., Mayor, Village of Hartville and received by this office on 18 December 2015 states “Wetland W-1 is a headwater wetland occurring near the northeast corner of the project area, sloping downward to the east offsite. The USGS 7.5-minute topographic map (Hartville Quadrangle) indicates an unnamed tributary offsite that this wetland slopes into. This tributary flows into Swartz Ditch, which then flows into Middle Branch Nimishillen Creek...”. Based on a review of the information provided as well as additional data available, we have determined, using best professional judgement, Wetland W-1 possesses a discrete surface hydrologic connection to an unnamed tributary to Middle Branch Nimishillen Creek, a relatively permanent water and indirect tributary to the Tuscarawas River, a traditional navigable water of the United States.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
