tributary system. In addition to being hydrologically isolated from a surface tributary system, Wetland A does not appear to support interstate or foreign commerce interests nor does it contain any rare or endangered species. Pond 1 is a man-made feature excavated in uplands with no surface hydrological connection to a surface tributary system. Additionally, there is a non-jurisdictional swale (Swale 1) that does not exhibit an ordinary high water mark, defined bed and bank, or wetland characteristics on site. The closest jurisdictional stream is located approximately 2,800 feet to the northwest and approximately 4,000 feet to the southwest of the project area. Additionally, the Scioto River, the nearest TNW, is approximately 6,500 linear feet away from the project area. Based on this information, Wetlands A is an isolated wetland and not a jurisdictional water of the United States. Pond 1 is also not considered a water of the United States..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
