wetlands (Wetlands A, B, C, and E), one (1) non-jurisdictional ditch (Ditch 1) and seven (7) non-jurisdictional retention ponds (Ponds 1 through 7) within the study area.

Wetland A (0.0073 acre) is a depressional wetland located near the southwestern corner of the project with a Cowardin classification of a palustrine emergent (PEM) wetland. Wetland A is part of a maintained mowed area and is located at the intersection of N. State Street, Old 3C Highway, and Mt. Royal Ave. Based on the Ohio Rapid Assessment Method Version 5.0 (ORAM) form, Wetland A is a category 1 wetland with an assessment score of 19 and is located approximately 598 feet from the nearest tributary system. Two small culverts were documented at the eastern and western limits of the wetland. The eastern culvert extends from Pond 7 into the wetland and the western culvert extends westward beneath N. State Street. Wetland A does not exhibit a surface water connection to a water of the United States, and no nexus to interstate or foreign commerce or does it contain any rare of threatened and endangered species. Therefore, this feature is not considered a jurisdictional water of the United States.

Wetland B (0.0099 acre) is a depressional wetland located near southwestern corner of the project with a Cowardin classification of a PEM wetland. Wetland B is part of a maintained mowed area and is located at the intersection of N. State Street, Old 3C Highway, and Mt. Royal Ave. Based on the ORAM form, Wetland B is a category 1 wetland with an assessment score of 12 and is located approximately 447 feet from nearest tributary system. Wetland B does not exhibit a surface water connection to a water of the United States, and no nexus to interstate of foreign commerce or does it contain any rare of threatened and endangered species. Therefore, this feature is not considered a jurisdictional water of the United States.

Wetland C (0.0210) is a depressional wetland located near the southeastern corner of the project and has a Cowardin classification of a PEM wetland. Wetland C is part of maintained mowed area and is located at the intersection of N. State Street and Chandler Court. Based on the ORAM form, Wetland C is a category 1 wetland with an assessment score of 9 and is located approximately 614 feet from the nearest tributary system. Wetland C does not exhibit a surface water connection to a water of the United States, and no nexus to interstate of foreign commerce or does it contain any rare of threatened and endangered species. Therefore, this feature is not considered a jurisdictional water of the United States.

Wetland E (0.0046) is a depressional wetland located near the northwestern corner of the project and has a Cowardin classification of a palustrine forested (PFO) wetland. Based on the ORAM form, Wetland E is a category 2 wetland with an assessment score of 41 and is located approximately 411 feet from the nearest tributary system. Wetland E does not exhibit a surface water connection to a water of the United States, and no nexus to interstate of foreign commerce or does it contain any rare of threatened and endangered species. Therefore, this feature is not considered a jurisdictional water of the United States.

Ditch 1 (356 lf) flows south to north along the eastern boundary of the project. Culverts are located at the northern and southern limits of the ditch, connecting Ditch 1 to Ponds 2 and 3. Ditch 1 does not exhibit a surface water connection to a water of the United States, and no nexus to interstate of foreign commerce or does it contain any rare of threatened and endangered species. Therefore, this feature is not considered a jurisdictional water of the United States.

Seven open water features (Ponds 1-7) were identified within the study area. These retention ponds were created through uplands during nearby residential construction to retain water from storm events. These ponds do not exhibit a surface water connection to a water of the United States, and no nexus to interstate of foreign commerce or does it contain any rare of threatened and endangered species. Therefore, these features are not considered jurisdictional waters of the United States.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
