Coverage of invasive species was sparse. Wetland A is positioned within a depression on the southwestern portion of the site and has a hydrological connection to the Scioto River via a roadside ditch that flows to Alum Creek then Big Walnut Creek. Big Walnut Creek is a direct tributary to the Scioto River, a TNW.**

Wetland D is a palustrine forested wetland comprising 1.07 acres located within the southeastern portion of the 40 acre site This wetland has established within a depression and is characterized as being dominated by green ash (*Fraxinus pennsylvanica*), silver maple (*Acer saccharinum*) and cattail sedge (*Carex typhina*). Wetland D is positioned within a depression on the southeastern portion of the site and has a hydrological connection to the Scioto River via a swale that connects to a roadside ditch that flows to Alum Creek then Big Walnut Creek. Big Walnut Creek is a direct tributary to the Scioto River, a TNW.

Summarize overall biological, chemical and physical functions being performed: **Wetlands A and D are forested wetlands. These wetlands provide filtering functions of sediment and pollutants prior to entry into Big Walnut Creek and stormwater storage capacity/function. The primary source of hydrology is most likely precipitation.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
