water connection to a water of the U.S. They are surrounded by uplands. In addition to being hydrologically isolate from a surface water tributary system, these wetlands do not appear to support interstate or foreign commerce interests nor does it contain and rare or endangered species. Therefore, Wetlands B and E are not considered jurisdictional waters of the United States.

Swales 1 and 2 are not tributaries of any RPW, they do not exhibit a defined bed or bank, nor an OHWM or wetland characteristics and lack any apparent significant nexus to a TNW. The swales identified on site are not considered jurisdictional waters of the United States. Stormwater Basin 1 was previously excavated for purposes of Section 402. Swales 1 and 2, and Stormwater Basin 1 are not considered jurisdictional waters of the United States.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The wetlands were likely created as a result of former activity and development, as well as possibly agricultural activity, and have no surface water connections to waters of the United States. Uplands surround the wetlands which makes them hydrologically isolated from a surface water tributary system.
