Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The features labeled as D.S. 3, 4, 5, and 6 were reviewed in the field. The features did not exhibit any OHWM or appear to exhibit wetland features. These features are located down-gradient of natural stream channels exhibiting OHWM's in the field. It has been determined that these features are non-jurisdictional upland features. It is, however, expected that these features serve as a hydrologic connection between up-gradient natural stream channels and down-gradient RPW's during flooding conditions, but not with a frequency or volume great enough to develop an OHWM. The up-gradient features were flowing during the 26 April 2016 visit and flow dissipated upon reaching the low-gradient valley after crossing the road via culverts, apparently seeping into the ground.

C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
