This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. of Lowes Boulevard. Stream 1 flows south for 177 linear feet before turning east and entering a culvert underneath Lowes Boulevard. On the eastern side of Lowes Boulevard Stream 1 enters Wetland B (a mosaic of open water area and wetland area), which exists as an impoundment of Stream 1. Stream 1 exits Wetland B via an existing water control structure on the eastern edge of the property and reforms into a natural channel. Stream 1 (RR-1) is an RPW and is a direct tributary to Compton Creek, which is a direct tributary to the North Fork of Paint Creek, which is a direct tributary of Paint Creek, which is a direct tributary to the Scioto River, a TNW

Describe flow regime: The applicant described the flow as intermittent. The stream had water with minimal flow (mostly pools) during the consultant's site visit in January 2016. Portions of the reach appears on the USGS topographic maps and is depicted as an intermittent stream within this reach before becoming perennial downstream. The reach within the study area has an abutting wetland (Wetland B).

Other information on duration and volume: See above. The duration of flow is likely shorter and the volume is likely higher than a natural stream due to the altered watershed due to the construction of the airport and high urbanization in this watershed.

Summarize overall biological, chemical and physical functions being performed: These wetlands reduce the magnitude, frequency, timing, and/or duration of flow within this highly developed watershed. These wetlands receive run-off from a high commercial traffic area and would retain and transform salts and pollutants and reduce their transportation to downstream waters. Finally, these wetlands would provide habitat for aquatic organisms.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

On the eastern side of Lowes Boulevard Stream 1 enters Wetland B (a mosaic of open water area and wetland area), which exists as an impoundment of Stream 1. Stream 1 exits Wetland B via an existing water control structure on the eastern edge of the property and reforms into a natural channel. The stream scored a 40 using Ohio EPA's Headwater Habitat Evaluation Index (HHEI) under Ohio EPA's Field Evaluation Manual for Ohio's Primary Headwater Habitat Streams (Ohio EPA 2005). Thus the stream is considered a Modified Class II. According to Ohio EPA's research, Class II streams support aquatic communities, process nutrients and sediment, dissipate energy, maintain stream energy dynamics, and maintain and protect downstream beneficial uses..
