Explain: **Based upon the information provided by the applicant and an on-site assessment by representatives of this agency performed September 14, 2016, there are eleven (11) non-jurisdictional, isolated wetlands (Wetlands A, B, C, D, E, G, H, I, J, K, and L) within the study area.**

Wetland A (0.41 acre), Wetland B (0.004 acre), Wetland D (0.02 acre), Wetland H (0.01 acre), Wetland I (0.009 acre), Wetland J (0.001 acre), Wetland K (0.008 acre) and Wetland L (0.03 acre) are all depressional wetlands located adjacent to Hillard Roam Road near the center and northern portion of the area of interest (AOI). Each wetland received a Cowardin classification of a palustrine emergent (PEM) wetland. All wetlands are part of an agricultural hay field and are located within the Department of Highways (DOH) right-of-way of Hillard Roam Road. Based on the Ohio Rapid Assessment Method Version 5.0 (ORAM) form, Wetlands A, B, D, H, I, J and K are category 1 wetlands with an assessment score of 16.5 and are located 3,476 feet from the nearest tributary system. Wetlands A, B, D, H, I, J and K do not exhibit a surface water connection to a water of the United States or a nexus to interstate or foreign commerce nor do they contain any rare or threatened and endangered species. Therefore, these features are not considered to be jurisdictional waters of the United States.

Wetland C (0.06 acre) is a depressional wetland located near western corner of the project with a Cowardin classification of a PEM wetland. Wetland C is part of an agricultural hay field and is located near residential homes. Based on the ORAM form, Wetland C is a category 1 wetland with an assessment score of 21.5 and is located approximately 4,166 feet from nearest tributary system. Wetland C does not exhibit a surface water connection to a water of the United States, or a nexus to interstate or foreign commerce and does not contain any rare or threatened and endangered species. Therefore, this feature is not considered a jurisdictional water of the United States.

Wetland E (0.01) is a depressional wetland associated with a storm water ditch and is located near the southeastern corner of the project and has a Cowardin classification of a PEM wetland. Wetland E is located near residential home with part being within a fenced pasture. Based on the ORAM form, Wetland E is a category 1 wetland with an assessment score of 19.5 and is located approximately 3,170 feet from the nearest tributary system. Wetland E does not exhibit a surface water connection to a water of the United States, or a nexus to interstate or foreign commerce, does not contain any rare or threatened and endangered species. Therefore, this feature is not considered a jurisdictional water of the United States.

Wetland G (0.03) is a depressional wetland located along the western part of the AOI and has a Cowardin classification of a PEM wetland. Based on the ORAM form, Wetland G is a category 1 wetland with an assessment score of 18.5 and is located approximately 3,573 feet from the nearest tributary system. Wetland G does not exhibit a surface water connection to a water of the United States, or a nexus to interstate or foreign commerce, and does not contain any rare or threatened and endangered species. Therefore, this feature is not considered a jurisdictional water of the United States.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
