created as a result of agricultural activity and development of the surrounding area and have no surface water connections to waters of the United States. Wetlands 1,2,5,7,13, and 14 are surrounded by uplands and do not exhibit a distinct surface water connection to a water of the U.S. The wetlands would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species. Therefore, Wetlands 1,2,5,7,13, and 14 are not waters of the United States.

The site also contains Ditch 2 (approximately 212 linear feet). Ditch 2 does not carry a relatively permanent flow of water, lacks an ordinary high water mark, defined bed and banks and wetland characteristics. Ponds 1,2,3,4,6, and 7 appear to be man-made, excavated water features that are deeper than 6.5 feet, not created by impoundment of a jurisdictional stream, and do not have a surface water connection to navigable water. The closest jurisdictional stream is an unnamed tributary to Walnut Creek located on the eastern portion of the site. Therefore, Ditch 2 and Ponds 1,2,3,4,6,7 are not waters of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
