- B. Typical year assessment(s):** A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data source, 16 April 2016 (Dry Season), with a corresponding APT report, were included in the evaluation for the excluded features onsite. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Wetland adjacency was assessed on 16 April 2016. Based on the antecedent precipitation tool, 16 April 2016 is included during the WebWIMP dry season and has a Palmer Drought Severity Index of -0.28 normal. The 30-day rolling total for precipitation was within the 30-year normal range. Therefore, site conditions are within that of a typical year. Wetland 1 was not considered adjacent and did not abut an (a)(2) stream.
