water connection to a water of the U.S. They are surrounded by uplands. In addition to being hydrologically isolate from a surface water tributary system, these wetlands do not appear to support interstate or foreign commerce interests nor does it contain and rare or endangered species. Therefore, Wetlands F, G, I, J, are not considered jurisdictional waters of the United States.

The site also contains other features that have been evaluated for possible jurisdiction, including Channel 1 (889 linear feet), Channel 2 (600 linear feet), Channel 3 (69 linear feet).

Channels 1-3 exhibited an ordinary high water mark and showed signs of defined bed and bank, but lacked a significant nexus or direct surface hydrological connection to any RPW or TNW. They did not exhibit a significant nexus to a TNW, therefore they are not considered jurisdictional waters of the United States.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Non-wetland waters (i.e., rivers, streams): **The study area contains three non-jurisdictional channels (Channels 1, 2, and 3) totaling 1,558 linear feet, that were likely created as part of past activities, including farming and development. They exhibit a defined bed and bank but do not exhibit signs of relatively permanent flow and appear to only convey water during and/or after large rain events at this point in time. The channels do not support hydrologic connections to waters of the United States and do not contribute to a surface water tributary system. The channels do not appear to support interstate or foreign commerce interests nor do they contain any rare or endangered species. Therefore, the channels are not considered waters of the United States.**

Wetlands: The approximate 144-acre property contains four non-jurisdictional wetlands (Wetlands F, G, I, and J) that total 2.23 acres. . The wetlands were likely created as a result of former activity and development, as well as possibly agricultural activity, and have no surface water connections to waters of the United States. Uplands surround the wetlands which makes them hydrologically isolated from a surface water tributary system. The wetlands do not appear to support interstate or foreign commerce interests nor does it contain any rare or endangered species. Therefore, the wetlands are no considered waters of the United States.
