The Cemex-Morris Bean Pipeline Upgrade Area of Interest (AOI) is characterized by a maintained right-of-way (ROW), county roads, and agriculture fields. On 11 October 2016, this office received an application for a Jurisdictional Determination titled Cemex-Morris Bean Pipeline Upgrade (dated 23 August 2016 and 3 September 2016) prepared by Utility technologies International (UTI). On 27 October 2016 representatives from the Corps and UTI conducted a site visit review. During this review of the project, the Corps requested additional information required to accurately describe and delineate waters within the Cemex-Morris Bean Pipeline Upgrade AOI. Additional information, and a request for a Department of Army (DA) Nationwide Permit No. 12 titled *Application for the Department of Army Permit*, dated 14 November 2016 was received by our office 17 November 2016.

Based on a review of the 23 August 2016 and 3 September 2016 reports submitted to our office, site verification conducted 27 October 2016, additional information received 17 November 2016, and other data available to us, this office has determined that only non-jurisdictional waters are present within the approved jurisdictional determination (JD) boundary. The approved JD boundary contains two (2) isolated, non-jurisdictional wetlands (0.137 acres).

Wetland W-1, and Wetland W-4 (0.137 ac): W-1, and W-4 are depressional wetlands that are located on a within a maintained ROW. The features are depressions and surrounded entirely by uplands. Hydrology enters the features from precipitation. The emergent wetland features do not possess a hydrologic surface or consolidated subsurface connection to a water of the U.S. Therefore, W-1, and W-4 are isolated, non-jurisdictional features, not subject to regulation under Section 404 of the CWA.

Refer to the enclosed *Cemex-Morris Bean Aquatic Resources – Approved JD Table*, and *Cemex-Morris Bean Jurisdictional Boundary Map* for a detailed summary of the non-jurisdictional features. The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States and Carabell v. United States*."

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
