agricultural activities and has no surface water connections to waters of the United States. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

A site visit conducted on May 3, 2017 concluded portions of Ditch 1 had a defined bed and bank and surface water flows. However, this was not observed throughout the entire length and there was no direct connection to a water of the United States. Ditch 1 flowed in a northerly direction and was located approximately 1,500 linear feet away from Wakatomika Creek. It was determined Ditch 1 was constructed in uplands to drain uplands and is not considered a jurisdictional water of the United States.
