- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: **Wetland A (0.039 acre) is located in the eastern central portion of the site, surrounded by upland forest, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce nor does it contain any rare or endangered species. The closest jurisdictional stream is an unnamed tributary to Killbuck Creek which is located approximately 2,200 linear feet east of Wetland A. It is a palustrine emergent wetland community**

dominated by *Imatiens capensis* (orange jewelweed), in addition to *Glyceria striata* (fowl mannagrass), *Bohemia cylindrica* (false nettle), and *Carex frankii* (Frank's sedge). Indicators of wetland hydrology included oxidized rhizospheres found on living roots, as well as surface soil cracks and met the FAC-neutral test. At the time of the on-site field investigation, surface water was present at a depth of 1-2 inches and a small hand-dug pool, covered by a tarp and thought to be a wildlife watering hole, was discovered. The hydric soil indicator was a depleted matrix. Wetland A is not considered to be a jurisdictional water of the United States.

Wetland B (0.004 acre) is located along the western central edge of the site, and is surround by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce nor does it contain any rare or endangered species. The closest jurisdictional stream is an unnamed tributary to Killbuck Creek, which is located approximately 2,650 linear feet east of Wetland B. It is a palustrine emergent wetland community dominated by *Typha x glauca* (hybrid cattail), with *Phalaris arundinacea* (reed canarygrass) and *Symphyotrichum lateriflorum* (calico aster) also present. Indicators of wetland hydrology include surface soil cracks and FAC-neutral test. At the time of the on-site field investigation, some surface water was present. The soil sample had low chroma colors and redoximprohic concentrations within the matrix, which qualified it for a depleted matrix indicator for hydric soil. Wetland B is not considered to be a jurisdictional water of the United States.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
