in the evaluation for the excluded features onsite. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Wetland adjacency was assessed on 9 July 2020. Based on the antecedent precipitation tool, 9 July 2020 is included during the WebWIMP dry season and has a Palmer Drought Severity Index of mild wetness. The 30-day rolling total for precipitation was lower than the 30-year normal range. Therefore, site conditions are drier than the typical year conditions. Wetland A is located approximately 185 linear feet south from Turkeyfoot Lake, an (a)(3)water. Due to the remote location of Wetland A, even during wetter than normal conditions, Wetland A would not be expected to be inundated by flooding from Turkeyfoot Lake in a typical year. Additionally, Wetland A is not physically separated from a water identified in paragraph (a)(1), (2), or (3) only by an artificial dike, barrier, or similar artificial structure.

**C. Additional comments to support AJD:** The property is located outside of the FEMA 100 year floodplain.
