of development and agricultural activities in the surrounding area. Wetlands A, B, C, D, E, F, G, H, and I are completely surrounded by uplands and have no distinct surface water connection to a water of the United States. The closest stream to the project site is approximately 1,300 linear feet east of Wetland G. Wetlands A, B, C, D, E, F, G, H, and I would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species. Therefore, Wetlands A, B, C, D, E, F, G, H, and I are not considered jurisdictional waters of the United States.

The site also contains Swale 1 (approximately 2,100 linear feet) and Pond 1 (approximately 0.06). The swale was likely created as a result of agricultural activities and has no surface water connections to waters of the United States. Swale 1 does not carry a relatively permanent flow of water, and does not exhibit an ordinary high water mark or defined bed and bank or wetland characteristics. Pond 1 appears to be man-made, excavated water feature that is deeper than 6.5 feet, has not been created by the impoundment of a jurisdictional stream, and does not have a surface water connection to traditional navigable waters. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
