C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetlands: The site contains four (4) non-jurisdictional wetlands (Wetlands A, B, C, and J) that total 0.44 acre.

Wetland A (0.24 acre) is located in the northwest portion of site and corresponds with a mapped National Wetlands Inventory (NWI) palustrine, forested, broad-leaved deciduous and temporary flooded (PFO1A) wetland. Wetland A is surrounded by uplands, with no surface water connection to a water of the United States, no nexus to interstate or foreign commerce, and the wetland does not provide suitable habitat for endangered species. Wetland A's isolation determination was verified during the 23 February 2017 on-site field investigation. Wetland A is a palustrine forested (PFO) wetland dominated by swamp white oak (*Quercus bicolor*), American elm (*Ulmus americana*), green ash (*Fraxinus pennsylvanica*), and an unknown sedge (*Carex sp.*). Indicators of wetland hydrology included high water table, saturation, and geomorphic position; depleted matrix was the indicator of hydric soil. Wetland A is not considered to be a jurisdictional WOUS.

Wetland B (0.06 acre) is located in the southwest portion of site and corresponds with a mapped NWI, PFO1A wetland. Wetland B is surrounded by uplands, with no surface water connection to a water of the United States, no nexus to interstate or foreign commerce, and the wetland does not provide suitable habitat for endangered species. Wetland B's isolation determination was verified during the 23 February 2017 on-site field investigation. Wetland B is a palustrine forested (PFO) wetland dominated by silver maple (*Acer saccharinum*), American elm (*Ulmus americana*), and hophornbeam (*Ostrya virginiana*) Indicators of wetland hydrology included surface water, high water table, saturation, sparsely vegetated concave surface, water-stained leaves and geomorphic position; depleted matrix and redox depressions were the indicators of hydric soil. Wetland B is not considered to be a jurisdictional WOUS.

Wetland C (0.01 acre) is located in the east-central portion of site. Wetland C is surrounded by uplands, with no surface water connection to a water of the United States, no nexus to interstate or foreign commerce, and the wetland does not provide suitable habitat for endangered species. Wetland C's isolation determination was verified during the 23 February 2017 on-site field investigation. Wetland C is a palustrine forested (PFO) wetland dominated by red maple (*Acer rubrum*), silky dogwood (*Cornus amomum*), green ash (*Fraxinus pennsylvanica*), wood reed grass (*Cinna arundinacea*), and calico aster (*Symphotrichum lateriflorum*). Indicators of wetland hydrology included surface water, high water table, and saturation; depleted matrix and redox depressions were the indicators of hydric soil. Wetland C is not considered to be a jurisdictional WOUS.

Wetland J (0.13 acre) is located in the west-central portion of site and corresponds with a mapped NWI, PFO1A wetland. Wetland J is surrounded by uplands, with no surface water connection to a water of the United States, no nexus to interstate or foreign commerce, and the wetland does not provide suitable habitat for endangered species. Wetland J's isolation determination was verified during the 23 February 2017 on-site field investigation. Wetland J is a palustrine forested (PFO) wetland dominated by shagbark hickory (*Carya ovata*), American elm (*Ulmus americana*), morrow honeysuckle (*Lonicera morrowii*), an unknown sedge (*Carex sp.*), wood reed grass (*Cinna arundinacea*), and calico aster (*Symphotrichum lateriflorum*). Indicators of wetland hydrology included high water table and saturation, depleted matrix was the indicator of hydric soil. Wetland J is not considered to be a jurisdictional WOUS.
