2. **Non-regulated waters/wetlands (check if applicable):**³

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

An on-site field verification was conducted on 8 May 2017. The entire area within the JD boundary has been disturbed by pre-law coal mining activities. According to the Ohio Department of Natural Resources - Mines of Ohio Viewer, the site was surface mined prior to 1961 and two underground mines from the 1930's are located on site. Mining related features observed on-site include un-reclaimed highwalls, excavated pits, access/haul roads, diversion ditches, spoil material, mining benches and constructed berms that have affected the drainage patterns at the site.

Open Water Ponds: Open water ponds EWI-2137, EWI-2077, EWI-2076 and EWI-2078 were created from previous mining activities that occurred at the site. A review of historical mapping indicates that this mining was conducted in uplands and the resulting features are excavated pits which are solely features of the excavation and/or incidental to the mining activity. Per the Preamble to the 1986 Regulations (FR 41217), under the discussion for Section 328.3 it clarifies that we generally do not consider certain waters to be "waters of the United States." Included in this are "water filled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of waters of the United States".

The open water features identified above were excavated in dry land for the purposes of mining activities, and though abandoned do not meet the definition of waters of the United States. These aquatic resources are geographically isolated, completely surrounded by uplands, exhibit no evidence of a hydrological connection to a water of the United States, and no apparent connection with interstate or foreign commerce or use for any irrigation purposes nor do they contain any rare or endangered species. Based on this information, open water ponds EWI-2137, EWI-2077, EWI-2076 and EWI-2078 are not jurisdictional waters of the United States.

Upland Swales/Linear Features: The linear features identified as ST-32, ST-33, ST-35, ST-36 and ST-36A were inspected and found to lack physical characteristics that would constitute an ordinary high water mark as described in Regulatory Guidance Letter 05-05. Although some portions of the linear features are narrow swales, the features do not exhibit disturbance of leaf litter, scour, sediment sorting or deposition of woody debris. In addition, there was commonly shrub/scrub and/or woody vegetation observed growing in the bottom of the linear features. ST-32, ST-33, ST-35, ST-36 and ST-36A were determined to be upland swales. The linear features identified as ST-37, ST-38 and ST-38A are located in a small area that was likely a historic drainage feature. However, these linear features lack physical characteristics that would constitute a reliable and continuous ordinary high water mark and a defined bed and bank. These features may have formed due to erosion caused by the adjacent access road and/or previous mining activities. This area has been widened by excavation and spoil material was deposited both parallel to and downgradient of the features. Linear features ST-37, ST-38 and ST-38A are also geographically isolated due to the deposition of spoil material and no potential surface water connection was observed during the field investigation. Based on this information, linear features ST-37, ST-38 and ST-38A were determined to be non-jurisdictional linear features.

The joint guidance memorandum signed by the Corps and the Environmental Protection Agency (EPA) on 2 December 2008, entitled Clean Water Act Jurisdiction Following the U.S. Supreme Court's Decision in *Rapanos v. United States & Carabell v. United States*, provides the following text regarding swales and erosional features: "swales or erosional features (e.g., gullies, small washes characterized by low volume, infrequent, or short duration flow) are generally not waters of the United States because they are not tributaries or they do not have a significant nexus to downstream traditional navigable waters."

Based on the information above, and other data available to us, linear features ST-32, ST-33, ST-35, ST-36, ST-36A, ST-37, ST-38, and ST-38A do not meet the definition of tributaries as listed in 33 CFR Part 328.3 (a) (5) and are not jurisdictional waters of the United States. These features have no apparent connection with interstate or foreign commerce or use for any irrigation purposes nor do they contain any rare or endangered species.

Roadside Ditch: An excavated roadside ditch was identified with the JD boundary. The roadside ditch was inspected during the site visit and no surface water was observed. The roadside ditch does not carry a relatively permanent flow of water, is not a tributary, nor does it have a significant nexus to a TNW. Based on this information, the roadside ditch was determined to be a non-jurisdictional feature.

The joint guidance memorandum signed by the Corps and the Environmental Protection Agency (EPA) on 2 December 2008, entitled Clean Water Act Jurisdiction Following the U.S. Supreme Court's Decision in *Rapanos v. United States & Carabell v. United States*, provides the following text regarding ditches: "ditches (including roadside ditches) excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water are generally not waters of the United States because they are not tributaries or they do not have a significant nexus to downstream traditional navigable waters."

Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
