A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Water storage, groundwater recharge, pollutant filtration, potential improvement of water quality to Impoundment (Mine Seep) and wildlife habitat. Wetland X was identified to have a significant nexus to Impoundment (Mine Seep) through a vegetated swale.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

SZ-2138 Impoundment (Mine Seep) receives flow from a groundwater seep (acid mine drainage). SZ-2183 Impoundment (Mine Seep) is a relatively permanent water, with the capacity to carry and/or increase the amount of pollutants reaching Rush Creek and the Hocking River, a TNW. Rush Creek has an aquatic life use designation of Warmwater Habitat (OAC-3745-1-24) and is on the State of Ohio's 303 (d) List of Prioritized Impaired Waters.

Wetland WTL-X (0.06 acre) is a low quality emergent wetland containing *typha augustifolia*, *phalaris arundinacea* and *juncus effusus*. Wetland X provides important ecological functions to the health of the watershed such as water storage, ground water recharge, sediment and pollutant filtration, improvement of water quality, and wildlife habitat. Water from Wetland X flows into SZ-2183 Impoundment (Mine Seep) which flows into an unnamed tributary of Rush Creek. Based upon a review of the information above, it has been determined that adjacent wetland WTL-X in combination with SZ-2138 Impoundment (Mine Seep), does have more than a speculative or insubstantial effect on the chemical, biological and physical integrity of Rush Creek and the Hocking River. Therefore, SZ-2138 Impoundment (Mine Seep) and Wetland X are determined to have a significant nexus on the Hocking River, a TNW.
