Approximately 364 linear feet of one (1) non-jurisdictional erosional feature was identified within the project area. Based on a review of the information provided and other information available, this feature is a remnant channel of George Geary Ditch. George Geary Ditch has been extensively modified both upstream and downstream of the project site by the installation of storm sewer systems to service surrounding residential and commercial developments. Utility mapping of the City of Dublin indicated flow from George Geary Ditch is captured in a 66" storm sewer pipe located west of the project area and diverted south, then east to empty to Cramer Ditch outside of the project area. The identified erosional feature no longer receives flow from George Geary Ditch, does not appear to carry relatively permanent flow, is completely surrounded by uplands, and does not present a hydrologic connection to any waters of the United States. The erosional feature does not exhibit characteristics of a stream or wetland, and terminates in uplands. For these reasons, the identified erosional feature is not considered a jurisdictional water of the United States.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
