feet). Ditches 1 and 2 do not carry a relatively permanent flow of water, lacks an ordinary high water mark, defined bed and bank, and wetland characteristics. Therefore, Ditch 1 and Ditch 2 are not waters of the United States.

The site also contains approximately 150 linear feet of three (3) swales (Swale 1, Swale 2, and Swale 3). The swales were likely created as a result of development of the surrounding area and have no surface water connections to waters of the United States. Swales 1, 2, and 3 do not carry a relatively permanent flow of water, and do not exhibit an ordinary high water mark or defined bed and bank, or wetland characteristics. Therefore, Swale 1, 2, and 3 are not considered jurisdictional waters of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
