2. **Non-regulated waters/wetlands (check if applicable):³**

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

The Crescent Valley Area of Interest (AOI) is characterized by past/pre SMCRA⁴ surface mining activities, access roads, impoundments, pit ponds, slips, and highwalls. Past mining activities have significantly altered the natural topography within the AOI. On 11 July 2017, this office received a request for a jurisdictional determination titled *Preliminary Jurisdictional Determination Report*, dated 26 June 2017, and prepared by Buckeye Mineral Services, Inc. (Buckeye) on behalf of Oxford Mining Company, LLC (Oxford). During this review of the project, the Corps requested additional information required to accurately describe and delineate waters within the Crescent Valley AOI. Additional information was received by our office 18 August 2017.

Based on a review of the 26 June 2017 report submitted to our office, additional information received 18 August 2017, and other data available to us, this office has determined that only non-jurisdictional waters are present within the approved jurisdictional determination (JD) boundary. The approved JD boundary contains eleven (11) isolated, non-jurisdictional streams totaling 6,357 linear feet (0.102 acre), eighteen (18) isolated, non-jurisdictional open water features (20.94 acre (acres)), and twenty-eight (28) isolated, non-jurisdictional wetlands (18.56 acres).

EWI-3, EWI-4, EWI-5, EWI-6, EWI-7, EWI-10, EWI-14, EWI-15, EWI-16, EWI-18, EWI-19, EWI-51, EWI-52, EWI-53, EWI-54, EWI-57, EWI-58, EWI-59, and EWI-62 (20.94 acres): EWI-3, EWI-4, EWI-5, EWI-6, EWI-7, EWI-10, EWI-14, EWI-15, EWI-16, EWI-18, EWI-19, EWI-51, EWI-52, EWI-53, EWI-54, EWI-57, EWI-58, EWI-59, and EWI-62 are depressional open water features that are located on multiple pit floors from past mining operations. The features are depressions and surrounded entirely by uplands. Hydrology enters the features from rainfall runoff and seeps discharging from coal seams. The open water features do not possess a hydrologic surface or consolidated subsurface connection to a water of the U.S. Therefore, EWI-3, EWI-4, EWI-5, EWI-6, EWI-7, EWI-10, EWI-14, EWI-15, EWI-16, EWI-18, EWI-19, EWI-51, EWI-52, EWI-53, EWI-54, EWI-57, EWI-58, EWI-59, and EWI-62 are isolated, non-jurisdictional features, not subject to regulation under Section 404 of the CWA.

Wetland P, Wetland Z, Wetland NN, and Wetland PP (11.56 acres): Wetland P, Wetland Z, Wetland NN, and Wetland PP are depressional wetlands with open water features. The features do not possess a hydrologic surface connection or consolidated subsurface connection to a water of the U.S. Therefore Wetland P, Wetland Z, Wetland NN, and Wetland PP are isolated, non-jurisdictional features, not subject to regulation under Section 404 of the CWA.

Wetland A, Wetland G, Wetland H, Wetland I, Wetland J, Wetland K, Wetland L, Wetland M, Wetland N, Wetland O, Wetland Q, Wetland R, Wetland X, Wetland Y, Wetland AA, Wetland BB, Wetland CC, Wetland DD, Wetland EE, Wetland FF, Wetland GG, Wetland II, and Wetland JJ (7.00 acres): Wetland A, Wetland G, Wetland H, Wetland I, Wetland J, Wetland K, Wetland L, Wetland M, Wetland N, Wetland O, Wetland Q, Wetland R, Wetland X, Wetland Y, Wetland AA, Wetland BB, Wetland CC, Wetland DD, Wetland EE, Wetland FF, Wetland GG, Wetland II, and Wetland JJ are depressional wetlands that do not possess a hydrologic surface connection or consolidated subsurface connection to a water of the U.S. Therefore Wetland A, Wetland G, Wetland H, Wetland I, Wetland J, Wetland K, Wetland L, Wetland M, Wetland N, Wetland O, Wetland Q, Wetland R, Wetland X, Wetland Y, Wetland AA, Wetland BB, Wetland CC, Wetland DD, Wetland EE, Wetland FF, Wetland GG, Wetland II, and Wetland JJ are isolated, non-jurisdictional features, not subject to regulation under Section 404 of the CWA.

Stream 3, Stream 4, Stream 5, Stream 6, Stream 7, Stream 8, Stream 10, Stream 26, Stream 27, Stream 28, and Stream 29 (6,357 lf or 0.102 acres): These ephemeral stream channels exhibited a defined bed and bank (DBB) and ordinary high water mark (OHWM) for 6,357 lf. Three (3) features (Stream 4, Stream 5, and Stream 26) drain into a pre-SMCRA pit floors, which are surrounded entirely by uplands. Stream 10

⁴ The Surface Mining Control and Reclamation Act (SMCRA) of 1977 (Public Law 95-87; 30 U.S.C. §1201-1328) establishes a nationwide program to protect society and the environment from the adverse effects of surface coal mining operations, and to set forth reclamation guidelines for surface coal mining areas. SMCRA was developed under the administration of the Office of Surface Mining, Reclamation and Enforcement, in the Department of Interior

flows off-site into a road side ditch that has no outlet, and is surrounded entirely by uplands. Stream 3, Stream 6, Stream 7, Stream 8, Stream 27, Stream 28, and Stream 29 are ephemeral stream channels that flow to a large system of interconnected wetlands and open water features that ultimately terminate to Wetland P which is surrounded entirely by uplands. There was no evidence of a hydrologic surface or consolidated subsurface connection to a water of the U.S. Therefore, this office has determined that these features are isolated, non-jurisdictional stream channels, not subject to regulation under Section 404 of the Clean Water Act (CWA).

Refer to the enclosed *Crescent Valley Aquatic Resources – Approved JD Table*, and *Crescent Valley Jurisdictional Boundary Map* for a detailed summary of the non-jurisdictional features. The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States and Carabell v. United States*."

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
