The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine

significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent water that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

Streams 1 and 2 are relatively permanent waters with intermittent flow regimes. Wetland A directly abuts Streams 1 and 2 at the confluence of the two tributaries. Streams 1 and 2 in conjunction with Wetland A convey storm water and surface runoff to the tributary system seasonally (intermittent flow) via an unnamed tributary to Salt Creek downstream to Salt Creek located outside of the study area. Intermittent streams reduce the pollution that flows downstream by retaining sediments and excess nutrients. Intermittent streams also have the ability to provide nutrients and organic carbon that support foodwebs for plants and wildlife downstream. Intermittent streams store nutrients in the form of detrital material that is carried into the receiving tributaries during precipitation events. This detrital material is a critical resource to many macro- and microorganisms that form the basis of the food chain in aquatic systems. Wetlands protect and improve water quality, provide fish and wildlife habitats, store floodwaters, and maintain surface water flow during dry periods. Streams 1 and 2 in conjunction with Wetland A have the capacity to carry pollutants or flood waters to the receiving TNW and/or have the capacity to reduce the amount of pollutants or floodwaters reaching the receiving TNW. Streams 1 and 2 in conjunction with Wetland A also have the capacity to transfer nutrients and organic carbon that support downstream foodwebs. Streams 1 and 2 are indirect tributaries to the Scioto River, the receiving TNW. Therefore, Streams 1 and 2 in conjunction with Wetland A provide more than a minimal or insubstantial effect on the chemical, physical, and biological integrity of the Scioto River.
