- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: **This is a dry, narrow channel that originates at an unimproved road constructed along the hillside. It is evident that the road diverts and carries surface runoff to a low section of the road, then downhill through an area that has no natural drainage topography. The surface runoff has eroded the channel along its path to the nearest tributary.**

This is a high gradient channel that is filled with loose eroded material, especially at its lowest end. Some live vegetation is seen in the loose material and in the lower-gradient section. The sides of the channel appear unstable with no discernable developed shelf or other mark (ordinary high water mark) impressed into the banks. No standing or flowing water was observed. These conditions indicate low flows of short duration. It is evident that if the road had not been constructed, this eroded feature would not have developed. No other natural stream connects to the channel. No channel exists updrain of the road. No adjoining or adjacent wetland exists.

Page 16 of the *U.S. Army Corps of Engineers Jurisdictional Determination Form Instructional Guidebook* states: “In accordance with the Rapanos Guidance...certain geographic features are not jurisdictional waters, including swales, erosional features (e.g. gullies) and small washes characterized by low volume infrequent and short duration flow. Considering the above, it has been determined this delineated feature is considered an erosional feature and is not a water of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
