Explain: **The 39 acre site contains features that have been evaluated for possible jurisdiction, including Wetland C (0.04 acre), Wetland E (0.17 acre), Ditch 1 (1,401 linear feet [lf]), Channel 2 (121 lf), Swale 1 (19 lf), Swale 2 (46 lf), Swale 3 (272 lf), Swale 4 (50 lf), and Swale 6 (40 lf).**

The approved JD boundary includes Wetland C, a 0.04 acre emergent wetland located on site and Wetland E, a 0.17 acre scrub-shrub wetland located on site. Wetland C and Wetland E exhibit no connectivity to any apparent stream channel or jurisdictional water of the United States. The closest jurisdictional stream is Rocky Fork that is located approximately 346 lf west of Wetland C and approximately 291 lf west of Wetland E. Wetland C and Wetland E would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species. This office has determined that Wetland C and Wetland E are isolated, non-jurisdictional features, not subject to regulation under Section 404 of the Clean Water Act (CWA).

The approved JD boundary also includes 1,949 lf of non-jurisdictional features located on the site. Ditch 1 (1,401 lf) is a roadside ditch that was constructed wholly in and draining only uplands. Ditch 1 does not carry a relatively permanent flow of water and lacks an ordinary high water mark, defined bed and banks, and wetland characteristics. Channel 2 (121 lf) does not carry a relatively permanent flow of water, lacks an ordinary high water mark, defined bed and banks, and wetland characteristics. Swale 1 (19 lf), Swale 2 (46 lf), Swale 3 (272 lf), Swale 4 (50 lf), and Swale 6 (40 lf) are erosional features in the landscape that exhibit no ordinary high water mark, defined bed and banks, or wetland characteristics. Therefore, Ditch 1, Channel 2, Swale 1-4, and Swale 6 are not considered jurisdictional waters of the United States.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the

tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
