interstate or foreign commerce. It is a palustrine forested (PFO) wetland dominated by a plant community consisting of *Quercus palustris*, *Acer rubrum*, *Rhamnus cathartica*, and *Leersia oryzoides*. Indicators of wetland hydrology included surface water, saturation, iron deposits, inundation visible on aerial imagery, water-stained leaves, surface soil cracks, crayfish burrows, geomorphic position, and FAC-neutral test, redox depressions was the indicator of hydric soil. Wetland A is not considered to be a jurisdictional water of the United States.

Wetland B (1.34 acre) is located in the central portion of site, occurring as a buttonbush swamp. Wetland B is surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. It is a palustrine forested / scrub-shrub (PFO/PSS) wetland dominated by a plant community consisting of *Cephalanthus occidentalis* and *Lycopus americanus*. Indicators of wetland hydrology included surface water, saturation, water marks, water-stained leaves, thin muck surface, moss trim lines, crayfish burrows, geomorphic position, microtopographic relief, and FAC-neutral test, black histic was the indicator of hydric soil. Wetland B is not considered to be a jurisdictional water of the United States.

Wetland C (0.10 acre) is located in the northwestern portion of site. Wetland C is surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. It is a PFO wetland dominated by a plant community consisting of *Acer rubrum*, *Ulmus Americana*, *Acer saccharinum*, and *Leersia oryzoides*. Indicators of wetland hydrology included saturation, sparsely vegetated concave surface, water-stained leaves, crayfish burrows, geomorphic position, and microtopographic relief, redox dark surface was the indicator of hydric soil. Wetland C is not considered to be a jurisdictional water of the United States.

Wetland D (0.12 acre) is located in the northwestern portion of site. Wetland D is surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. It is a PFO wetland dominated by a plant community consisting of *Acer rubrum*, *Quercus bicolor*, *Acer saccharinum*, *Populus deltoides*, *Agrostis gigantea* and *Leersia oryzoides*. Indicators of wetland hydrology included saturation, sparsely vegetated concave surface, water-stained leaves, moss trim lines, crayfish burrows, and geomorphic position, depleted matrix was the indicator of hydric soil. Wetland D is not considered to be a jurisdictional water of the United States.

Wetland E (0.55 acre) is located in the northwestern portion of site. Wetland E is surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. It is a PFO wetland dominated by a plant community consisting of *Acer rubrum* and *Juncus tenuis*. Indicators of wetland hydrology included saturation, sparsely vegetated concave surface, water-stained leaves, moss trim lines, crayfish burrows, and geomorphic position, depleted matrix was the indicator of hydric soil. Wetland E is not considered to be a jurisdictional water of the United States.

Wetland F (1.95 acre) is located in the northern portion of site. Wetland F is surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. It is a PFO wetland dominated by a plant community consisting of *Toxicodendron radicans* and *Phragmites australis*. Indicators of wetland hydrology included saturation, water-stained leaves, surface soil cracks, crayfish burrows, and geomorphic position, redox dark surface was the indicator of hydric soil. Wetland F is not considered to be a jurisdictional water of the United States.

Wetland G (0.18 acre) is located in the central portion of site. Wetland G is surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. It is a PFO wetland dominated by a plant community consisting of *Juncus tenuis* and *Scirpus cyperinus*. Indicators of wetland hydrology included high water table, water-stained leaves, surface soil cracks, geomorphic position, and FAC-neutral test, redox dark surface was the indicator of hydric soil. Wetland G is not considered to be a jurisdictional water of the United States.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW.

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
