commerce. The closest jurisdictional stream is on site approximately 500 linear feet southeast west of Wetland 1, approximately 950 linear feet to the east of Wetland 2, and approximately 200 linear feet southeast of Wetland 3. Wetlands 1, 2 and 3 do not support commercial fish species and are not used for agricultural irrigation. Approximately 719 linear feet of four (4) non-jurisdictional erosional features (Swales 1-4) were identified within the project area. The identified erosional features do not appear to carry relatively permanent flow, are completely surrounded by uplands, and do not present a hydrologic connection to any waters of the United States. The erosional features do not exhibit characteristics of a stream or wetland, defined bed or bank, and terminate in uplands. Approximately 242 linear feet of one (1) non-jurisdictional ditch (Ditch 1) was identified within the project site. Ditch 1 is a roadside ditch and was likely created as a result of development of the surrounding area. Ditch 1 has no surface water connection to waters of the United States, does not carry relatively permanent flow, does not exhibit an ordinary high water mark, defined bed and bank, or wetland characteristics. For these reasons, the Wetland 1-3, Swales 1-4, and Ditch 1 are not considered jurisdictional waters of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
