Explain: **The approximately 33-acre site consists of an agricultural field with standing corn and mowed/maintained vacant land. No streams are present on-site and the nearest stream is approximately 1 mile away. Approximately 1,250 linear feet of one (1) drainage ditch was observed onsite and crossing the western portion of the property in a**

southeast to northeast direction. The drainage ditch appears to begin offsite on the adjoining Springfield Beckley Municipal Airport parcel located to the east of the project site. No standing water or flowing water was observed in the drainage ditch during the site visit on 23 October 2017 by the agent, GCI. It appears the ditch was constructed in 2012 for storm water management at the Springfield Beckley Municipal Airport and the Airpark Ohio commercial development sites and lacks a defined bed, bank and ordinary high water mark. The ditch extends offsite and to the north where vacant land and a Bob Evans distribution facility adjoins the property. No wetlands, ponds or other waters were observed by GCI on the property during the 23 October 2017 site visit. The project area is surrounded by agriculture and the Springfield Beckley Municipal Airport including some commercial businesses and individual residential houses. No obvious hydrological connection to the tributary system was noted and there was no indication of commerce.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
