Explain: **Pond 1 (0.35 acre) is an open water feature identified within the study area and is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this pond consists of mowed lawn. This feature would not support interstate or**

foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States.

Pond 2 (0.09 acre) is an open water feature identified near the center of the study area and is surrounded by wetland fringe (Wetland A). It does not exhibit a surface water connection to a water of the United States, and nor a nexus to interstate or foreign commerce. The land surrounding this feature consists of mowed lawn. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States.

Wetland A (0.04 acre) is location in the central portion of the property and consists as palustrine emergent wetland fringe around Pond 2. It is surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The closest jurisdictional stream is an unnamed tributary to Cottage Grove Lake which is located approximately 410 linear feet northwest of Wetland A. The dominant plant community of the emergent wetland consists of *Leersia oryzoides* (rice cut-grass), with *Lycopus americanus* (American bugleweed) and *Juncus tenuis* (slender rush) also present. Primary indicators of hydrology observed included evidence of surface water from Pond 2, as well as iron deposits, inundation visible on aerial imagery, and aquatic fauna. The soil sample documented exhibited signs of naturally problematic hydric soils, likely due to the proximity to a man-made pond, and consisted of mucky layers and met the A10 hydric soil indicator. Wetland A is not considered to be a jurisdictional water of the United States.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
