- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The site contains two (2) isolated wetlands (Wetlands 1 and 2, totaling 0.13 acre, located within the 62- acre project site. These wetlands are located in a depression in uplands, surrounded by uplands and lack a surface water connection to the tributary system of the Little Miami River. These wetlands are determined to be isolated with no hydrologic connection to the tributary system and no substantial nexus to interstate or foreign commerce. Wetlands 1 and 2 are not considered waters of the United States and are non-jurisdictional (Isolated) wetlands. In addition, one (1) pond, totaling less than 0.1 acre, is present in the central portion of the site near Wetland 2, and was constructed by excavating in uplands and creating an earthen berm along the sides of the pond to capture precipitation and runoff. The pond does not have a discharge point and is not connected to any tributary system. Therefore, the pond is not considered a water of the United States.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

In addition, one (1) pond, totaling less than 0.1 acre, is present in the central portion of the site near Wetland 2, and was constructed by excavating in uplands and creating an earthen berm along the sides of the pond to capture precipitation and runoff. The pond does not have a discharge point and is not connected to any tributary system. Therefore, the pond is not considered a water of the United States..
