The approved JD boundary includes Wetland A, a 0.10 acre emergent wetland located in a depression in the northern portion of the study area. The plant community in Wetland A is dominated by narrow leaf cattail (*Typha angustifolia*), common rush (*Juncus effusus*), and sedges (*Carex sp.*). The source of wetland hydrology for Wetland A is saturation, surface water, and geomorphic position. The soil sample located within Wetland A (SP-14) exhibited the hydric soil indicator of a depleted matrix. Wetland A is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to the Olentangy River that is located approximately 2,311 linear feet east of Wetland A. Wetland A would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland B, a 0.10 acre emergent wetland located in a depression in the north-central portion of the study area. The plant community in Wetland B is dominated by Indian hemp (*Apocynum cannabinum*) and sedges (*Carex sp.*). The source of wetland hydrology for Wetland B is saturation and surface water. Water stained leaves were also observed. The soil sample located within Wetland B (SP-3) exhibited the hydric soil indicator of a depleted matrix. Wetland B is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to the Olentangy River that is located approximately 2,460 linear feet east of Wetland B. Wetland B would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland C, a 0.04 acre emergent wetland located in a depression in the east-central portion of the study area. The plant community in Wetland C is dominated by narrow leaf cattail (*Typha angustifolia*) and sedges (*Carex sp.*). The source of wetland hydrology for Wetland C is saturation, surface water, and geomorphic position. Additionally, saturation was visible on aerial imagery. The soil sample located within Wetland C (SP-5) exhibited the hydric soil indicator of a depleted matrix. Wetland C is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to the Olentangy River that is located approximately 2,546 linear feet east of Wetland C. Wetland C would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland D, a 0.07 acre emergent wetland located in a depression in the central portion of the study area. The plant community in Wetland D is dominated by narrow leaf cattail (*Typha angustifolia*) and sedges (*Carex sp.*). The source of wetland hydrology for Wetland D is saturation and surface water. Additionally, saturation was visible on aerial imagery. The soil sample located within Wetland D (SP-7) exhibited the hydric soil indicator of a depleted matrix. Wetland D is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to the Olentangy River that is located approximately 2,615 linear feet east of Wetland D. Wetland D would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland E, a 0.01 acre scrub-shrub wetland located in a depression in the north-central portion of the study area. The plant community in Wetland E is dominated by cottonwood (*Populus deltoides*), Indian hemp (*Apocynum cannabinum*), and aster (*Symphyotrichum sp.*). The source of wetland hydrology for Wetland E is saturation, surface water, and a sparsely vegetated concave surface. Water stained leaves were also observed. The soil sample located within Wetland E (SP-12) exhibited the hydric soil indicator of a depleted matrix. Wetland E is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to the Olentangy River that is located approximately 2,262 linear feet east of Wetland E. Wetland E would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

This office has determined that Wetlands A, B, C, D and E are isolated, non-jurisdictional features, and not subject to regulation under Section 404 of the Clean Water Act (CWA).

**A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
