Explain: **The 230-acre site contains nine features that have been evaluated for possible jurisdiction, including Wetland 5 (0.006 acre), Wetland 10 (0.100 acre), Wetland 11 (0.234 acre), Wetland 13 (0.081 acre), Wetland 15 (0.029 acre), Wetland 16 (0.023 acre), Wetland 17 (0.009 acre), Wetland 19 (0.167 acre), and Wetland 6-Site 2 (0.136 acre).**

The approved JD boundary includes 0.482 acre of seven emergent wetlands; Wetland 5 (0.006 acre), Wetland 10 (0.100 acre), Wetland 11 (0.234 acre), Wetland 13 (0.081 acre), Wetland 15 (0.029 acre), Wetland 16 (0.023 acre), and Wetland 17 (0.009 acre). The approved JD boundary includes 0.303 acre of two forested wetlands: Wetland 19 (0.167 acre) and Wetland 6-Site 2 (0.136 acre).

Wetland 5, Wetland 10, Wetland 11, Wetland 13, Wetland 15, Wetland 16, Wetland 17, Wetland 19, and Wetland 6-Site 2 exhibit no connectivity to any apparent stream channel or jurisdictional water of the United States. The closest jurisdictional stream is an unnamed tributary to the South Fork Licking River which is located approximately 1,254 linear feet (lf) north of Wetland 5, 1,272 lf east of Wetland 10, 1,338 lf east of Wetland 11, 1,286 lf east of Wetland 13, 754 lf east of Wetland 15, 926 lf east of Wetland 16, 872 lf east of Wetland 17, 679 lf east of Wetland 19, and 445 lf west of Wetland 6-Site 2. Wetland 5, Wetland 10, Wetland 11, Wetland 13, Wetland 15, Wetland 16, Wetland 17, Wetland 19, and Wetland 6-Site 2 would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species. This office has determined that Wetland 5, Wetland 10, Wetland 11, Wetland 13, Wetland 15, Wetland 16, Wetland 17, Wetland 19, and Wetland 6-Site 2 are isolated, non-jurisdictional features, and not subject to regulation under Section 404 of the Clean Water Act (CWA).

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the

tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
