The Approved JD Boundary contains 6,150 linear feet (LF) of 31 Non-Jurisdictional Ditches. The project site is located along two existing roads, Sellers Road and Next Road, in Tyler County, West Virginia, that contain roadside ditches.

Ditches 1 through 18 and Ditches 21 through 33 (Ditch 1: 10 LF, Ditch 2: 90 LF, Ditch 3: 70 LF, Ditch 4: 130 LF, Ditch 5: 250 LF, Ditch 6: 10 LF, Ditch 7: 450 LF, Ditch 8: 325 LF, Ditch 9: 420 LF, Ditch 10: 10 LF, Ditch 11: 400 LF, Ditch 12: 75 LF, Ditch 13: 300 LF, Ditch 14: 450 LF, Ditch 15: 70 LF, Ditch 16: 225 LF, Ditch 17 225 LF, Ditch 18: 80 LF, Ditch 21: 80 LF, Ditch 22: 900 LF, Ditch 23: 150 LF, Ditch 24: 80 LF, Ditch 25: 250 LF, Ditch 26: 200 LF, Ditch 27: 80 LF, Ditch 28: 75 LF, Ditch 29: 120 LF, Ditch 30: 40 LF, Ditch 31: 25 LF, Ditch 32: 80 LF, Ditch 33: 480 LF,) are man-made, non-jurisdictional features. Ditches 1 through 18 and Ditches 21 through 33 were dug wholly in uplands, are draining wholly uplands, and have less than relatively permanent flow. Ditches 1 through 18 and Ditches 21 through 33 are not captured tributaries; are man-made drainage features that were constructed for roadside drainage and are evident in historical aerial imagery from 1972. As per the 1986 Regulations Preamble, 2007 U.S. Army Corps of Engineers Jurisdictional Determination Form Instructional Guidebook, and the 2008 Rapanos Guidance, Ditches 1 through 18 and Ditches 21 through 33 are not considered waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
