Swale 15 (91 linear feet), Swale 16 (15 linear feet), Swale 17 (16 linear feet), Swale 18 (1,263 linear feet), Swale 19 (31 linear feet), Swale 20 (70 linear feet), Swale 21 (103 linear feet), Swale 22 (68 linear feet), and Excavated Feature 1 (0.03 acre).

The approved JD boundary includes Wetland A, a 0.01 acre scrub-shrub wetland, Wetland B, a 0.06 acre emergent wetland, Wetland C, a 0.03 acre forested wetland, Wetland M, a 0.02 acre emergent wetland, Wetland N, a 0.17 acre forested wetland, Wetland O, a 0.80 acre forested wetland, and Wetland R, a 1.51 acres emergent and scrub-shrub wetland complex. Wetlands A, B, C, M, N, O, and R exhibit no connectivity to any apparent stream channel or jurisdictional water of the United States. The closest jurisdictional stream to Wetland A is an unnamed tributary to Peters Run which is located approximately 1,953 linear feet north of Wetland A. The closest jurisdictional stream to Wetland B is an unnamed tributary to Peters Run which is located approximately 2,015 linear feet north of Wetland B. The closest jurisdictional stream to Wetland C is an unnamed tributary to Peters Run which is located approximately 1,423 linear feet north of Wetland C. The closest jurisdictional stream to Wetland M is an unnamed tributary to Peters Run which is located approximately 1,543 linear feet north of Wetland M. The closest jurisdictional stream to Wetland N is an unnamed tributary to Peters Run which is located approximately 1,800 linear feet north of Wetland N. The closest jurisdictional stream to Wetland O is an unnamed tributary to Peters Run which is located approximately 1,562 linear feet north of Wetland O. The closest jurisdictional stream to Wetland R is an unnamed tributary to the Scioto River which is located approximately 351 linear feet west of Wetland R. Wetlands A, B, C, M, N, O, and R would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species. This office has determined that Wetlands A, B, C, M, N, O, and R are isolated, non-jurisdictional features, and not subject to regulation under Section 404 of the Clean Water Act (CWA).

The approved JD boundary also includes Ditch 1 (1,525 linear feet), Ditch 2 (580 linear feet), Swale 1 (1,236 linear feet), Swale 2 (625 linear feet), Swale 3 (666 linear feet), Swale 4 (177 linear feet), Swale 5 (125 linear feet), Swale 6 (24 linear feet), Swale 7 (75 linear feet), Swale 8 (373 linear feet), Swale 9 (409 linear feet), Swale 10 (160 linear feet), Swale 11 (216 linear feet), Swale 12 (713 linear feet), Swale 13 (460 linear feet), Swale 14 (154 linear feet), Swale 15 (91 linear feet), Swale 16 (15 linear feet), Swale 17 (16 linear feet), Swale 18 (1,263 linear feet), Swale 19 (31 linear feet), Swale 20 (70 linear feet), Swale 21 (103 linear feet), Swale 22 (68 linear feet), and Excavated Feature 1 (0.03 acre). Ditch 1 and Ditch 2 are ditches with ephemeral flow that were excavated wholly in and draining only uplands. Swales 1-22 are erosional features in the landscape that exhibit no ordinary high water mark, defined bed and banks, or wetland characteristics. Excavated Feature 1 is an open water feature constructed in dry land. Therefore, Ditch 1-2, Swales 1-22, and Excavated Feature 1 are not considered jurisdictional waters of the United States.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
