The Approved Jurisdictional Determination (AJD) contains 21 non-jurisdictional ditches, totaling 4,349 linear feet (LF). The project site is located along an existing road, Wetzel Tyler Ridge Road (CR 44), south of Atwood, in Tyler and Wetzel Counties, West Virginia. The ditches within the AJD Boundary include the following : ASE_Ditch01a (558 LF), ASE_Ditch01b (107 LF), ASE_Ditch02a (189 LF), ASE_Ditch02b (227 LF), ASE_Ditch02c (184 LF), ASE_Ditch02d (104 LF), ASE_Ditch03a (158 LF), ASE_Ditch03b (135 LF), ASE_Ditch03c (147 LF), ASE_Ditch04a (134 LF), ASE_Ditch04b (291 LF), ASE_Ditch04c (96 LF), ASE_Ditch04d (180 LF), ASE_Ditch04e (291 LF), ASE_Ditch04f (414 LF), ASE_Ditch05a (229 LF), ASE_Ditch05b (211 LF), ASE_Ditch05c (108 LF), ASE_Ditch05d (120 LF), ASE_Ditch06 (405 LF), and ASE_Ditch07 (61 LF). The ditches are man-made, non-jurisdictional roadside features.

The ditches were dug wholly in uplands, are draining wholly uplands, and have less than relatively permanent flow. ASE_Ditch01a, ASE_Ditch01b, ASE_Ditch02a through ASE_Ditch02d, ASE_Ditch03a through ASE_Ditch03c, ASE_Ditch04a, through ASE_Ditch04f, ASE_Ditch05a through ASE_Ditch05d, ASE_Ditch06, and ASE_Ditch07 are not captured tributaries; are man-made drainage features that were constructed for roadside drainage and are evident in historical aerial imagery from 1957. As per the 1986 Regulations Preamble, 2007 U.S. Army Corps of Engineers Jurisdictional Determination Form Instructional Guidebook, and the 2008 Rapanos Guidance, Ditches: ASE_Ditch01a, ASE_Ditch01b, ASE_Ditch02a through ASE_Ditch02d, ASE_Ditch03a through ASE_Ditch03c, ASE_Ditch04a, through ASE_Ditch04f, ASE_Ditch05a through ASE_Ditch05d, ASE_Ditch06, and ASE_Ditch07 are not considered waters of the U.S.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
