Explain: **The 51-acre site contains features that have been evaluated for possible jurisdiction, including Wetland C (1.54 acres), Wetland F (0.07 acre), Wetland G (0.15 acre), Wetland H (0.32 acre), Wetland I (0.28 acre), Wetland J (0.09 acre), and Swale 1 (318 linear feet).**

The approved JD boundary includes Wetland C, a 1.54 acres emergent wetland, Wetland F, a 0.07 acre emergent wetland, Wetland G, a 0.15 acre emergent wetland, Wetland H, a 0.32 acre scrub-shrub wetland, Wetland I, a 0.28 acre emergent wetland, and Wetland J, a 0.09

acre emergent wetland. Wetlands C, F, G, H, I, and J exhibit no connectivity to any apparent stream channel or jurisdictional water of the United States. The closest jurisdictional stream to Wetland C is Stream 1, the South Fork Licking River, which is located approximately 220 linear feet northeast of Wetland C. The closest jurisdictional stream to Wetland F is Stream 1, the South Fork Licking River, which is located approximately 450 linear feet east of Wetland F. The closest jurisdictional stream to Wetland G is Stream 1, the South Fork Licking River, which is located approximately 353 linear feet east of Wetland G. The closest jurisdictional stream to Wetland H is Stream 1, the South Fork Licking River, which is located approximately 482 linear feet east of Wetland H. The closest jurisdictional stream to Wetland I is Stream 1, the South Fork Licking River, which is located approximately 1,005 linear feet east of Wetland I. The closest jurisdictional stream to Wetland J is Stream 1, the South Fork Licking River, which is located approximately 1,180 linear feet east of Wetland J. Wetlands C, F, G, H, I, and J would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species. This office has determined that Wetlands C, F, G, H, I, and J are isolated, non-jurisdictional features, and not subject to regulation under Section 404 of the Clean Water Act (CWA).

The approved JD boundary also includes 318 linear feet of one (1) non-jurisdictional feature. Swale 1 is a 318 linear feet erosional feature in the landscape that exhibits no ordinary high water mark, defined bed and banks, or wetland characteristics. Therefore, Swale 1 is not considered a jurisdictional water of the United States.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a

TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
